1. The licensee must comply with the Food Act 2006 and Food Standards Code - Food Safety Standards.
2. The licensee must, at all times, have a food safety supervisor who is reasonably available to be contacted.
3. The fit out of the premises must remain in accordance with the approval issued by Council. No structural alterations are to be carried out without prior approval from Council.
4. Council is to be notified within seven (7) days of any significant change to the activity of the food business.
5. The licensee must allow reasonable access to an authorised person during normal business hours.
6. The licensee must display the licence, or a copy of the licence, in a prominent position at the premises so it is easily visible to persons at the premises.
7. The licensee must maintain the accredited Food Safety Program and have it available on-site at all times for inspection by employees in the food business.
8. The licensee must comply with the accredited Food Safety Program for the food business.
9. The licensee must allow an auditor to have reasonable access to the licensee's premises under the licence to conduct audits under the Food Act 2006.
